



Becoming a BID Member

All Manor Royal BID Levy Paying companies are invited to become a member of the Manor Royal Business District (MRBD) Limited BID Company, the registered not-for-profit company limited by guarantee, which is charged with the responsibility for delivering the Business Improvement District Plan. Membership of MRBD Limited is open and <u>FREE</u> to all Manor Royal Business District levy payers and offers you access to all MRBD Limited events and services and the opportunity to vote on all BID Company issues at Annual General Meetings.

What does it mean to be a BID member?

By contacting the BID Office and declaring your interest in becoming a member of MRBD Limited you are declaring you have the required responsibility and authority to do so and entitlement to vote on matters affecting the BID on behalf of your company. Only registered members of MRBD Limited are entitled to attend AGMs, nominate themselves or a fellow BID Member to become a Director of the Company and other "members only" meetings. Only those companies who have paid their BID levy are entitled to vote on matters affecting the Manor Royal BID.

Who is entitled to become a BID member?

Representatives from companies in the Manor Royal BID area who are BID levy payers. Only registered members of MRBD Limited are entitled to attend AGMs and other "members only" meetings. Only those companies who have paid their BID levy are entitled to vote on matters affecting the Manor Royal BID. Each company is entitled to one member and one vote.

How to become a member?

To become a BID Company member simply contact the MRBD Office by letter or email specifically declaring your interest in becoming a member.

Other ways to become involved

Being a member of MRBD Limited is not the only way to become involved in the operation and delivery of the Manor Royal BID. The involvement of as many Manor Royal companies as possible is actively encouraged. You can get involved and influence the way in which the BID levy is spent by being a part of one of the working groups that cover the main project areas, you can become involved in more strategic issues via the Management Group or by getting in touch to offer your ideas and input.
