Then they emptied all their content from the large bag that they were holding. But the individuals then left store swearing and still making threats. I then got a basket and tried to assist a member of staff to put the stolen items in, so we could check the price of all the products. My colleague was at this time outside in the carpark, with shoplifters as the police was also called. As I walked outside, I could see the male shoplifter walking towards my colleague and the other security, with what looks like a hockey stick in his hand. I shouted to the shoplifter to refrain in his actions, has he looked like he was going to assault one of the security officers. The male shoplifter then walked back to his car, not long after the police arrived and both male/ female shoplifter was arrested and taken away.
