New Pocket Park 'The Terrace' Opened





Keith Pordum, Vice-Chair of the Manor Royal BID joined Patrick Heath-Lay, Chief Executive Officer of B&CE, The People's Pension, on 28 April 2017 to officially open 'The Terrace' - a peaceful outdoor 'pocket park' located at the end of Manor Royal road at the junction with London Road.

The opening ceremony saw members of the Manor Royal BID Board and local business people gather to announce 'The Terrace' officially open. Designed to provide outdoor space for those who work nearby, The Terrace is now an ideal place for alfresco meetings, relaxing lunchtime breaks or simply a breath of fresh air. Converted from a patch of unused land, the area provides seating, public art, an outdoor table tennis table and a new planting scheme for local employees to enjoy. Conceived and delivered by the Manor Royal BID, the project has been funded via BID Levy funds, a section 106 contribution from Crawley Borough Council and sponsorship from B&CE, The People's Pension, whose offices are located adjacent to the site.

Keith Pordum, Vice-Chair of Manor Royal BID is enthusiastic for what the opening of The Terrace will do for Manor Royal Business District. He said: "In recent months, we have seen several new and exciting high density developments taking shape on Manor Royal. We wanted to complement these by creating a new area of outdoor space," he said. "It is fitting that work on site here began on 9 January 2017, the 70th anniversary of Crawley becoming a new town." Patrick Heath-Lay, Chief Executive Officer of B&CE, The People's Pension, is delighted to be part of the new pocket park: "We are always looking for new ways to make a positive impact on our local community, so we are delighted to support the Manor Royal BID with this new and innovative project.

> BID Projects Update

Transport Study



Transport, parking and congestion are concerns not just for Manor Royal but for all major towns, cities and business parks around the country.

Since 2013, Manor Royal Business District has enjoyed significant growth coupled with high levels of incommuting. This has led to pressure on local roads and parking infrastructure - something highlighted in recent surveys conducted by the BID.

In response, the Manor Royal BID commissioned specialist transport consultants Steer Davies Gleave to assess the real impact this is having and to evaluate a range of possible actions to help the BID (and our partners at West Sussex County Council, Crawley Borough Council, Metrobus and others) to address what is a difficult and expensive challenge.

The resulting Manor Royal BID Transport Study made a number of recommendations and has become the foundation for focusing our work in this area. Some of the recommended infrastructure changes to roads, junctions and roundabouts will take time and frankly a lot of money.

Some are already funded (primarily to improve cycle and pedestrian links), and others will be delivered on the back of planned development in the area e.g. along Gatwick Road.

However, there are other recommendations that will be dependent on the success of us attracting more funds to Manor Royal – something the BID Team and partners are working on.

Another part of the Transport Study looks at how more parking might be created by converting grass verges that are no longer serving a useful purpose. It also considers how such space might be more pro-actively managed. Again, it's a big job to convert verges and undertake a review of our district's parking restrictions, but this is now planned to happen later this year. The final part of the puzzle is how we make it more attractive to get here by means other than by car. Not easy and not possible for all, but certainly something we are looking at.

The unpalatable truth remains that there is not enough parking for everyone and the Transport Study makes some recommendations about behaviour change. It highlights that an amazing 83,000 people of working age live within a commutable cycle ride and 8,200 within walking distance yet just 2.8% of us cycle and 6.6% of us walk to work. More than 22,000 people drive into/out of Manor Royal daily and that doesn't account for visitors!

If you haven't already seen it, the Manor Royal Transport Study is available to view on the Projects pages of the Manor Royal BID website. We continue to work with our partners and expect to announce more on this over the coming months.
