Metcalf Way / County Oak Way



Location:

The site is formed of 2 sections of footpath located between Metcalf Way and County Oak Way, situated along bridleway 1525 1.

The site is the pedestrian and cycle link between Metcalf Way and County Oak Way. The site is well used as a cut through between these two roads and has an existing footpath, vegetation and traveller defence grass mounds and bollards at either end.

The site is within Manor Royal Zone 1 (yellow)

The site also forms part of Bridleway 1525 1 connecting Country Oak Way to Langley Green.

Site Features:

- The site forms part of a bridleway that follows 110m of County Oak Way and follows a footpath 98m to Metcalf Way and continues on to Langley Green;
- Grass bunds 0.7m high and yellow bollards are situated either end of the site aimed to stop vehicles entering the site;
- The existing tarmac path is 98m long and varies in width from 1.8m at the entrances to 2.6m;
- The grass margin either side of the path is between 2.5-5m wide and finishes at a drainage ditch on either side of the site and is 1.0-1.5m deep;
- At the Metcalf Way entrance there is a section of brick wall protecting the fall into the drainage ditch, a Manor Royal monolith next to a telegraph pole;
- Towards Metcalf Way is a litter and dog waste bins; and
- The site includes the area of footpath and • adjoining drainage ditch / vegetation along County Oak Way.

Metcalf Way / County Oak Way

Design Intent:

'A distinctive art-scape corridor to sit, socialise and soak up the sun'.

The connection between Metcalf Way and County Oak Way already provides a useful off road pedestrian / cycle / bridle way link and forms part of a wider network of off road green links and drainage corridors.

The intent is to create a series of connected and distinctive areas for seating and meeting, whilst maintaining the direct path / link between Metcalf Way and County Oak Way.

There will be a reduction in visual clutter of existing furniture such as unsightly bollards, traveller defence grass bunds and the mixture of different fences.

The drainage channels will enhanced through clearance of invasive weeds and planting native vegetation along its edges.

Strategically placed 'artistic' retaining walls and incidental seating walls will create attractive and useful spaces to sit, socialise and / or just soak up the sun.

The position, angle and rhythm of the spaces transform the whole corridor into a sculptural and distinctive land form. The park becomes the art. But also provides opportunity for further public art intervention such as stories, patterns and textures applied to the retaining walls and incidental seating.

The edges provide opportunity for more environmental based public art that could help better connect the community to their local environment and perhaps climate adaptation innovation and action.
