#### LITTER EXPERIMENTATION

### **DATA**


In July we collected 51 bags of litter from the floor. In August we collected 60 bags which has shown a slight increase. Potentially this could be due to the summer Weather.

These quantities will continue to be reviewed monthly to take into account seasonal variation and hopefully improvements in amount of litter on the floor. Due to the warm Weather in August it is possible to suggest this had an increase in litter on the floor due to higher footfall.

All litter experiments are still ongoing as stated in previous reports. The only new issues are-

## **TERRACE**

Extra emptying of the bin at the Terrace, continued in August. We have reported that Alcohol consumption is happening and has been reported to the Rangers to monitor, this is during out of hour work hours. Cigarettes are being thrown on the floor rather than be stubbed out in the Bin top Ash Tray. (May need to considerer some type of Ash Tray dispenser)



#### PRIESTLEY WAY

Encouragingly, this area has significantly improved regards to litter issues.

#### **METCALF WAY**

Litter has started to increase around Metcalf Way and County Oak, litter is blowing over from the new Retail Park. This is still continuing to happen.

#### **MAXWELL WAY**

Litter has started to escalate at the end of Maxwell way and Gatwick Road. Evidence is suggesting these areas are wind traps. Trial bins may be required but we do not believe it is dropped litter through footfall.

# REPORTS, INFORMATION AND FEEDBACK

- As the report suggests, we are still having litter issues in certain Zones. However, encouragingly we are experiencing less litter in the majority of Manor Royal as a whole. There was an increase on litter from the floor during Aug, however as in the previous month due to the summer weather.
- As previously mentioned increase of alcohol consumption in Terrace Park during the evenings. Rangers to Monitor and feedback their findings.
- Zone 4 blitz work has been completed, regards to encroachment and vegetation. Edging of paths to be addressed during Autumn/winter as previously stated.
- Uniform has been success. Individually staff are being noticed, could require more Hi Visual Vests.
- To date we have completed eleven grass cuts.
- Started the process of edging up in Zone 1 in between Blitz work and general maintenance (data to be provided in next month's report)
- Emergency cut backs completed to improve public safety carried out in Zone 3
- Extra weed spraying carried out in Zones 1 and 4 as some weeds looked unsightly
- Started working relations with the new Rangers. Attended a site visit to discuss issues and hot spot areas.
- Doorsan Babcock met with members of the team to discuss future project outdoor work days for staff.
- Continue to receive positive feedback regards to the service.
- Oil Spillage was found in Priestley Way, this has been reported to West Sussex County Council to deal with.
